## Security & Public Safety Quote

**Peace Officers:** These persons will be Commissioned by an authorized Law Enforcement Agency of the state of Texas (County, Municipal, State, Special District, etc.) to provide Traffic Control of the roadway and entrance to the property. They will investigate and manage any traffic related incidents which occur on the highway, respond to emergency situations as well as coordinating with other agencies responding to emergencies both on the property and roadway.

**Security Officers:** These persons will be licensed as either Armed or Unarmed Security Officers responsible for providing safety of patrons, crowd control, deterring criminal activity, and responding to emergencies which may occur during the event. These individuals shall be in a clearly identified security uniform and be placed on either a static or roving position.

**Emergency Medical Services:** These persons will be certified/licensed medical providers (ECA, EMT, AEMT or Paramedic) responsible for providing first aid and treating any immediate life threats as well as communicating with County EMS and other responders regarding medical emergencies which occur during the event

**Fire Watch:** These persons will be responsible for providing controlling the number of persons entering the property by ensuring they have proper passes, wristbands or proper clearance (i.e., Vendors, First Responders, etc.) to enter the event. Additionally, they will monitor the parking areas and venue for fire hazards or fires should they occur and advise the event staff of such. Fire watch personnel will coordinate with event staff and security to ensure no more than 2500 persons enter the venue and any unauthorized persons are removed from the event.
